Bruce G. Resnick is the Joseph M. Bryan Professor of Banking and Finance at the Babcock Graduate School of Management of Wake Forest. His research interests include efficiency of options and futures markets and empirical tests of asset pricing. A major focus is the optimal design of internationally diversified portfolios controlled for parameter uncertainty and exchange rate risk. In recent years, Professor Resnick has investigated international portfolio investment strategies applying information in the yield curve. His research has been published in major academic journals in finance. Bruce Resnick is an associate editor for the Journal of Financial Research, Journal of Multinational Financial Management and the Journal of Economics and Business.
