Texas*. *Clark* addresses whether the admission against the defendant of a young child's allegation of abuse, made out of court and offered in lieu of the child's testimony at trial, violated the defendant's confrontation right. *Warger* raises questions concerning the application of Rule 606(b). And *Salinas* examines the prosecution's use in its case-in-chief of a suspect's silence in response to noncustodial police questioning.

The supplement also addresses the Supreme Court's recent grant of certiorari in *Peña-Rodriguez v. Colorado*. The Court will consider whether the Sixth Amendment's guarantee of an impartial jury overcomes Rule 606(b) and its state-law equivalents and permits defendants to present juror testimony about case-related expressions of ethnic bias in the jury room. Oral argument is set for October 11, 2016.
